Publication of the book "Misconceptions about Slums in France"

DIHAL is a partner of the book "Misconceptions about Slums in France", published on 12 January 2016 by the French publishing house Editions du Cavalier Bleu. How many slums are there in France today? Who lives there? What is life like in a slum? How do you get out of this situation? These are some of the questions which guided the authors, Hervé Marchal, Lecturer in Social Sciences at the University of Lorraine, Jean-Baptiste Daubeuf, PhD student, and Thibaut Besozzi, Doctor of Sociology. On publication of the book, two of the three co-authors, Hervé Marchal and Jean-Baptiste Daubeuf, answered some questions from DIHAL's "illegal camps / slum clearance" division.

Why did you write a book on the misconceptions of slums when it is commonly said that everyone already knows about slums?

Hervé Marchal: Exactly! Thinking that we know does not always mean we do know. Slums are the object of many prejudices and stereotypes that we wanted to identify and analyse.

Which misconceptions do you think are likely to hinder slum clearance actions? **HM**: Slums and encampments are associated with the clichéd "Epinal image" of Roma and Gypsies. However, the reality is much more nuanced, complex and diverse. Bringing the question of slums back to an alleged cultural affiliation amounts to having a very basic understanding of the actual situation.

You talk about self-fulfilling prophecies. What do you mean by that?

Jean-Baptiste Daubeuf: Cultural belief produces its own effects: it leads to the social marginalisation of populations identified as Roma, who in return tend to retreat to a claimed culture.

What is your view of the State's action and, more generally, of the actors involved in the issue of slums? HM: The State is a coordinator, a mediator who tries to provide guidance to all of the actors on the ground. This remote action may seem vague, but it also gives freedom.

And Europe?

JBD: A framework remains to be set for social action on a European level, to put social support in place for poor European populations. Europe seems too involved in a culturalist approach to avoid the slope of radical relativism.

How do you compare your work to existing works on the subject? JBD: This work is not committed in the sense that it does not seek to adopt a position, but it is in the sense that it aims to analyse a current urban social reality in order to suggest a sense of direction for politics. From this point of view, it is complementary to many other works on the subject.

In your opinion, what are the areas to explore for the future?

HM: We believe that researchers have a real added value to bring to state or associative actors. In light of this, we envisage a sociological study of the slums (in its economic, social and humanitarian aspects) in order to account for the great heterogeneity of the slums.

OPCALIA Project: closure of the language training course at the Stains AFPA (French National Agency for Adult Vocational Training) in Seine-Saint-Denis

On 13 January 2017, a meeting was held to close OPCALIA's trial linguistic and professional integration programme in Stains. This programme enabled 14 people from slums to receive training in the French language. Ten of the participants have already found employment or training, in the laundry, construction, security and landscaping sectors. The strong involvement from these trainees, who were in a very precarious situation, was underlined. This project was initiated by DIHAL, together with the Prefecture of Ile-de-France and DIRECCTE (French Regional Directorates for Enterprise, Competition, Consumer Affairs, Labour and Employment). Relocation of families from the slums of Lyon to Luzy in Nièvre

In 2015, the Rhone prefecture undertook a major operation to clear the three major slums in the Greater Lyon area, with the implementation of an **ambitious scheme to rehouse and support** families in widespread housing and at two temporary insertion sites (12E scheme). Two families from these sites have recently been relocated to Luzy in Nièvre. In this small town of 2,000 inhabitants, a large mobilisation of the commune, the department, the social services and the association Habitat & Humanisme allowed these two families (four adults and four children) to

Publication of the CEREMA (French Centre for Studies and Expertise on Risks, Environment, Mobility and Development) report on the application of the circular of 26 August 2012 "in 4 cases and 6 questions"

After four years of applying the 26 August 2012 circular, DIHAL asked the French Centre for Studies and Expertise on Risks, Environment, Mobility and Development (CEREMA) to study the conditions of implementing the circular and the results of the actions carried out in the field. CEREMA studied four regions:

Strasbourg, **Bordeaux**, **Lille** and **Lyon**. Specific general lessons were taken from the analyses of the circular's application.

The ROMACT Programme meeting in Munich

A meeting organised by the European Commission and the Council of Europe on the ROMACT Programme on "**Cooperation on a local level and capacity building for the inclusion of marginalised populations**" was held in Munich on 15 and 16 December 2016. This event, in which DIHAL participated, provided the opportunity to present several transnational cooperation experiences, such as the "Atlas" network in Antwerp, the "Roma Matrix" project in Glasgow, the MixCité 113 project 380 hours of training, these women are offered jobs as mediators either within the framework of an employment contract or as volunteers. This system has important repercussions in terms of the effectiveness of global intervention towards families and changes in attitudes.

The President of the Republic welcomes the success of the Romcivic project, winner of "La France s'engage" (France is committed) label

The Romcivic programme, supported by DIHAL, is one of the **30 projects selected to receive the "La France s'engage" label**. The President of the Republic also honoured this programme during the launch of the Foundation for Social Investment and Human Development on 17 January 2017. Since its launch in 2014, the Romcivic programme has enabled 92 young people from slums to carry out civic service. More than half of them are now in a position of professional integration.

DIHAL met with the Association of Cities of the Catholic Relief Services (ACSC) on 10 January 2017. Since 2014, the ACSC has been implementing a project for the displacement of slums and supporting families in Aix-en-Provence and

Meeting with the Essonne DDCS (Departmental Commission for Social Cohesion)

On 4 January 2017, DIHAL met with the assistant director of Essonne's (91) Departmental Commission for Social Cohesion (DDCS), which is responsible for monitoring the clearance of illegal camps. On taking office, she wished to take stock, with DIHAL, of who will join the DDCS in a visit to the camp site in Ris-Orangis. **Marseilles.** This project supports 24 families through accommodation, schooling and professional integration. This meeting made it possible to bring up the difficulties encountered by the association, as well as the possibility of redirecting actions.

Meeting with the Quatorze Association

On 9 January 2017, DIHAL met with the Quatorze Association, which is made up of architects who work on inclusive project methods, in partnership with the inhabitants and beneficiaries of the constructions. The association has taken action on several sites in Ile-de-France (Montreuil, Trielsur-Seine) and in Metz. It was envisaged that the association could participate in DIHAL's work on security problems.
